Minutes of the 38th Executive Committee (EC) meeting of National Mineral Exploration Trust (NMET) held on 29th November, 2024 at Khanij Kaksh, Shastri Bhawan, New Delhi

The 38th meeting of Executive Committee (EC) of NMET was held under Chairmanship of Shri V. L. Kantha Rao, Secretary, Mines/Chairman EC on 29th November, 2024 at Shastri Bhawan, New Delhi in hybrid mode. The list of participants is given in Annexure-1.

Shri Vivek Kumar Bajpai, Joint Secretary, Mines welcomed all the members, invitees and other participants in the meeting. The details of agenda points discussed and decisions taken in the meeting are given below:

Agenda 38.1: Confirmation of minutes of 37th Meeting of EC held on 23rd September, 2024.

The minutes of the 37th EC meeting were circulated on 16th October, 2024. No comments were received from the members.

Decision of EC: EC confirmed the minutes of the 37th Executive Committee (EC) meeting of National Mineral Exploration Trust (NMET). Further, EC instructed that henceforth the minutes of the meeting be circulated within 7 working days.

Agenda 38.2: Action Taken Report (ATR) on the minutes of 37th EC meeting.

EC was briefed on the action taken on decisions taken during the 37th EC meeting. Discussion on the actionable points is given below:

Discussions:

 As regards, organising workshop on EL regime, Chairman, EC advised that the EL workshop be organised by Mines-VI section as soon as the EL blocks are auctioned. NMET will fund the workshop.

[Action: Mines VI]

ii. Regarding the advice of Secretary, Mines to DGM, Maharashtra to submit more exploration projects to NMET for funding (agenda point 37.7.i), Dr. TRK Rao,

D. G., DGM informed that 4 proposals have been submitted and 4 more proposals will be submitted in next 15 days. It was advised that several NPEAs have been notified and some of them are from Maharashtra, which can be encouraged for taking up exploration projects in Maharashtra State through NMET fund.

[Action: DGM, Maharashtra]

iii. As regards, the direction of EC to carry out Quality Check and Capacity Assessment of MECL and NPEAs, to assess their capability for carrying out exploration of REE and Critical Minerals (Agenda point no. 37.7.ii), the EC was apprised that a committee was constituted on 4/3/2024 headed by Chairman of TCC with the mandate to carry out the capacity assessment of the agencies. In continuation to that, the committee has assessed the capacity of all the agencies and observed that two agencies namely Critical Mineral Trackers and Bhushilp Mining do not have sufficient number of field geologists to execute exploration projects. As regards the quality check of the agencies, EC was apprised that GSI has formulated and circulated an SoP to monitor the work executed by the NPEAs and check the quality.

In this regard, Chairman, EC instructed (a) to issue advisory to the aforesaid agencies for hiring sufficient manpower to execute projects and (b) an online workshop be organised to provide training to the DDGs of State Units on the SoP for clarity and uniformity.

iv. Regarding the direction of Chairman, EC to DMG, Madhya Pradesh for facilitating M/s Engeotech to carry out phosphate exploration in the State (Agenda point 37.7.iv), Shri Sohan Baghel, Dy. Director, DMG, MP informed the house that M/s Engeotech had applied for forest permission in respect of Devpur Manakpura phosphate block in Parivesh Portal and accordingly permission of 15 days has been provided to the agency to carryout sampling during field work. As regard the exploration in Jhalauthar Phosphorite block the agency has not yet applied for forest permission. Chairman, EC directed DMG, MP to actively follow up with Forest Department to facilitate M/s Engeotech to carry out exploration.

v. Deputy Secretary and HoD, NMET informed the house that AMD has shared 33 reports with various State Governments in last 5 years and the report in respect of Bhatikheda block was submitted to Rajasthan Government. Director, AMD informed that in the last two years more than 2000 samples were collected from that area and were analysed. The resource updation is being carried out and updated GR would be submitted to the State Government within 15 days. Shri Vivek Kumar Bajpai, Joint Secretary, Mines requested Director, AMD to provide reports to the Ministry of Mines in respect of blocks where critical minerals are found during investigations carried out by AMD. In continuation to that Director, AMD informed that Kamthai deposit of Rajasthan contains REE which can be taken up for auction.

Chairman, EC instructed that the requisite data be collected from AMD and the Bhatikheda & Kamthai blocks be put up for auction in the upcoming tranche.

vi. DG, GSI stated that the geo-coordinates of NMET funded projects and their spatial distribution should be uploaded in NGDR portal.

Chairman, EC instructed to provide the available shape files to GSI for uploading on NGDR portal. Further, Chairman, EC instructed to add advisory in the sanction order that final payment to the agencies would be disbursed when the report is uploaded on NGDR portal.

Decision of EC: EC accepted the Action Taken Report on the minutes of 37th EC meeting.

Discussions

i. Dr. L.S Sekhawat, DDG, GSI (Retd.) and Technical Expert, EC apprised the house that in many areas the concentration of TiO2 is found to be more than 10% which is considered as economically viable. TiO2 is mostly present in Ilmenite and Rutile and contains good amount of Vanadium (V) and Scandium (Sc) which is a rare element having economical value. Therefore, the TiO2 values should be studied properly for possibilities of Vanadium and Scandium. He further informed the house that bentonitic clays in Gujarat have a very good concentration of Vanadium and may be further studied/utilised properly.

Some areas near Kamthai deposit in Rajasthan are having REEs along with LREEs where concentration of LREE is mostly less than 1000 ppm. It needs to be considered whether such low values of LREE are worth for G4/G3 level investigation.

Chairman, EC observed that Vanadium and Scandium being important elements, are worth exploring even when concentration is low. Some R&D projects can be taken up to explore the possibility of extracting such elements.

ii. Dr. Sahendra Singh, Professor and Technical Expert, EC citing the recent gold discovery in China, informed the house that the avenues of seismic survey in

deep seated and critical minerals may be explored, in addition to coal exploration. In continuation to that, DG, GSI informed that GSI would carry out MT survey in the brownfield areas to ascertain the depth continuity of the ore bodies. Regarding including seismic survey in other commodities apart from coal, DG, GSI pointed out that GSI is doing DSRS survey as a part of pilot project. Based on the outcome of the study, further course of action would be decided.

iii. Shri Alok Sharma, Technical Expert, EC stated that the report of the committee to include seismic survey in coal exploration may be circulated early so that the larger area can be explored. Chairman EC, directed the committee to submit the report early.

iv. Smt. Nirupama Kotru, Joint Secretary and Financial Advisor, Mines pointed out that with time NMET is funding more projects and increasing its budget expenditure progressively. GSI and the State Governments should identify areas having potential for deep seated minerals and aggressively focus on increasing the exploration activities in those areas.

v. In his concluding remarks, Chairman, EC advised DG, GSI and NMET to explore the strategies for enhancement of mineral exploration activities and utilisation of Rs. 600 crores in the next financial year.
