Ministry of Mines National Mineral Exploration Trust Minutes of 40th Executive Committee (EC) meeting, NMET held on 21.2.2025 Venue: Khanij Kaksh, Shastri Bhawan

The 40th meeting of Executive Committee (EC) of NMET was held under Chairmanship of Shri V. L. Kantha Rao, Secretary, Mines/Chairman EC on 21st February, 2025 at Shastri Bhawan, New Delhi in hybrid mode. The list of participants is given in Annexure-1. Shri Vivek Kumar Bajpai, Joint Secretary/Member Secretary, EC welcomed the chairman EC, all members, technical experts and invitees in the meeting. The points discussed and decisions taken in the meeting are as under:

Agenda 40.1: Confirmation of minutes of 39th Meeting of EC held on 24th January, 2025.

The minutes of the 39th EC meeting were circulated on 6th February, 2025. No comments received from the members.

Decision: EC confirmed the minutes of the 39th meeting of Executive Committee (EC).

Agenda 40.2: Action Taken Report (ATR) on the minutes of 39th EC meeting

EC was briefed on the action taken on decisions taken during the 39th EC meeting. Discussion on the actionable points is given below:

i. In the matter of organizing a workshop on EL regime, EC was apprised that Roadshow on EL regime will be organized in the month of March, 2025 and accordingly workshop will be planned.

[Action: Mines-IV]

ii. Regarding the surveillance assessment reports of NPEAs by QCI Nabet, Chairman, EC instructed that it should be completed at the earliest and a representative from QCI-Nabet should brief the issue in the upcoming EC meeting.

[Action: MINES-I/QCI-Nabet]

iii. As regards the auction of Bhatikheda block explored by AMD, the EC was apprised that the GR is being evaluated by MECL and the matter is being monitored by Mines-IV.

EC instructed MECL to fast track the evaluation of report pertaining to Bhatikheda block for auction in consultation with AMD.

[Action: Mines-IV and MECL]

iv. Regarding uploading of reports of NMET funded exploration projects in NGDR portal, EC was informed that 177 reports have already been uploaded in NGDR portal out of 237 reports and rest of the reports will be uploaded by the end of February, 2025.

[Action: NMET]

v. Regarding the evaluation of report submitted by the committee on "Inclusion of seismic survey in coal exploration", EC was apprised that the comments have been received from Ministry of Coal on 21.2.2025 and the same have been forwarded to the committee to finalise the report. The committee was directed to finalize the report within 31.3.2025 and thereafter share the same with NMET Secretariat for further implementation by concerned agencies.

[Action: MoPNG and MoC]

vi. Chairman, EC advised Ministry of Coal to circulate the SoP prepared jointly by GSI and CMPDIL to explore critical minerals/ other minerals associated with coal among the NPEAs for information and further action. Further, Chairman, EC instructed Ministry of Coal to issue a letter to CMPDIL to look for critical minerals/other minerals in the dumps and tailings of coal mines.

[Action: Ministry of Coal]

vii. As regards the engagement of NPEAs in coal exploration, EC was apprised that the matter is being reviewed by the Policy Division of Ministry of Coal. MoC was requested to expedite the matter.

[Action: Ministry of Coal]

viii. Regarding the evaluation of 2600 geological reports of various State Governments for their geological potential, Chairmen of TCCs informed that so far around 200 reports have been identified for further evaluation. The TCC Chairmen requested for 02 weeks' time to evaluate these reports.

Chairman, EC instructed Director (Tech.), MoM to arrange a review meeting around 10th March, 2025 to assess the outcome of these 200 reports.

Discussion:

i. * EC instructed DGM, Maharashtra to provide the available data of the earlier leasehold area to MECL so that the results can be utilized by MECL during exploration of limestone in Dhunki-Chillai block, Yavatmal district, Maharashtra.

[Action: DGM, Maharashtra/MECL]

ii. Chairman, TCC-2 informed that CGM, Gujarat has identified nearly 200 mineral blocks by engaging private agencies and allotted such blocks to several NEAs/NPEAs for exploration. EC instructed that NMET should study the methodology adopted by CGM, Gujarat and subsequently NMET Secretariat should send a letter to all the State DMGs/DGMs to suitably adopt the good practice to enhance exploration activity in the respective states.

iii. #EC instructed MECL to collect all the reports from HZL pertaining to the area in and around Hirnoda block in Rajasthan before initiating the exploration work.

[Action: MECL]

iv. EC enquired whether NPEAs can participate in the auction of bulk minerals in respect of blocks explored by them through NMET funding. EC instructed to apprise the details in the upcoming meeting.

[Action: NMET/Policy Section]

v. ##The project proposal of DGM, Nagaland namely, "Preliminary Exploration (G-3) for Limestone in Khongkha Block, Kiphire district, Nagaland" was discussed in detail. The representative of DGM, Nagaland explained that this block was previously explored at G-4 stage by DGM, Nagaland with their own fund. This time they have submitted a proposal at G-3 stage from NMET fund.

EC instructed that a committee including members from GSI, MECL and IBM should visit the said limestone block and submit a report within one month on the commercial viability of Composite License at G-4 stage or whether the block can be upgraded to G-3 stage of investigation.

Decision: EC accorded financial approval of ₹36.38 crore (Rupees thirty six crore and thirty eight lakh only) for 12 new project proposals recommended by TCC-1 and TCC-2 and deferred 02 projects at SI. no. 11 and 13.

Chairman, TCC-2 apprised that financial assistance from NMET fund to procure machinery and equipment, namely ICP-MS, was approved to DGM, Jharkhand in 28th EC meeting held on 16th March 2023 and sanction order was issued on 18th August, 2023 within a timeline of 12 months. While finalizing the specification of ICP-MS it was observed that Ultra Pure Water System is also required with the instrument as an accessory and a proposal to procure Ultra Pure Water System was submitted by DGM, Assam. TCC-2 in its 5th meeting has recommended the procurement of Ultra Pure Water System as an accessory without any cost implication.

Decision: EC accorded approval for procurement of Ultra Pure Water System as an accessory item of ICP-MS without any cost implication.

Agenda 40.7: Discussion on procurement of Mineral Liberator Analyzer by CSIR-IMMT, Bhubaneshwar

Chairman, TCC-1 apprised that CSIR-Institute of Mineral and Material Technology (IMMT), Bhubaneshwar is developing a Centre of Excellence for Processing of Rare Earth and Strategic Minerals by procuring Mineral Liberator Analyzer (MLA), which is an important equipment for mineral quantification to characterize the ore minerals and plays a vital role in prospecting new reserves, processing and extraction of metals.

Subsequently, CSIR-IMMT had submitted a proposal to procure Mineral Liberator Analyzer (MLA) with an estimated cost of Rs. 7.85 crores vide letter no. D/R&D/2024 dated 18.6.2024. TCC-1 in its 67th meeting had suggested CSIR-IMMT to cross check the details of MLA procurement with GSI and NGRI. Subsequently, CSIR-IMMT has submitted a revised proposal with upgraded specification of MLA in 71st TCC for an amount of Rs. 13.50 crores including GST, custom duties, warranty and post warranty AMC after consultation with GSI and NGRI

TCC at its 71st meeting has recommended the proposal of CSIR-IMMT for procurement of one Mineral Liberator Analyzer with an estimated cost of Rs. 13.50 crores including GST, custom duties, warranty and post warranty AMC with a timeline of 12 months for approval.

Discussion:

Chairman, TCC-1 apprised that, CSIR-IMMT would be the only public funded institute in India having advanced level Mineral Liberator Analyzer facility which would cater to the needs of Government and private agencies. Procurement of Mineral Liberation Analyzer would strengthen Indian mineral processing research capabilities and expand the horizons of developing process flowsheets for low grade complex ores. Presently, CSIR-IMMT is extending mineral characterization and beneficiation facilities to various agencies like CMPDI, DST, KIOCL, Ministry of Mines, Steel, NALCO, NMDC, Tata Steel, Jindal Steel, HZL and many other agencies.

He further informed that presently there is no such scheme as per which NMET can provide financial assistance to Govt. PSUs and research organizations for procurement of equipments. However, NMET had earlier approved financial assistance to MECL and CMPDI on case to case basis to procure scientific equipments for augmenting capacity building in research advancement with the approval of Hon'ble Union Minister of Coal and Mines.

AS&FA informed the house that Parliamentary Standing Committee has raised an issue regarding actual capital investment done through NMET fund and suggested to examine the matter.

Joint Secretary, Mines and Member Secretary, EC apprised that earlier such projects were approved on case to case basis with the approval of Hon'ble Minister of Mines. Further, as NMET is going to support the National Critical Mineral Mission (NCMM) of Ministry of Mines by funding several R&D projects, NMET can have a provision of approving such proposals by Executive Committee.

Decision of EC: EC instructed to examine the issue separately.
