## National Mineral Exploration Trust Minutes of 43<sup>rd</sup> Executive Committee (EC) meeting, NMET held on 14.8.2025

Venue: Khanij Kaksh, Shastri Bhawan

The 43<sup>rd</sup> meeting of Executive Committee (EC) of NMET was held under Chairmanship of Shri V. L. Kantha Rao, Secretary, Mines/Chairman EC on 14<sup>th</sup> August, 2025 at Shastri Bhawan, New Delhi in hybrid mode. The list of participants is given in Annexure-1. Smt. Geetika Sharma, Dy. Secretary & HoD, NMET welcomed the Chairman, EC and introduced Shri Pankaj Garg, Director General, NMET and Member Secretary, EC. She also welcomed all the members, technical experts and invitees at the meeting. The agenda items discussed and decisions taken in the meeting are as under:

#### Agenda 43.1: Confirmation of minutes of 42<sup>nd</sup> Meeting of EC held on 2<sup>nd</sup> June, 2025.

The minutes of the 42<sup>nd</sup> Executive Committee (EC) meeting were circulated on 12th June, 2025. No comments or observations were received from the members.

**Decision:** EC confirmed the minutes of the 42<sup>nd</sup> meeting of Executive Committee.

#### Agenda 41.2: Action Taken Report (ATR) on the minutes of 42<sup>nd</sup> EC meeting

EC was briefed on the action taken on decisions taken during the  $42^{nd}$  EC meeting. Discussion on the actionable points is given as under:-

Regarding monitoring mechanism to track the manpower of NPEAs every six months, QCI-Nabet informed that: (i) a standardized form has been prepared to capture detailed information pertaining to the joining and leaving of experts across all relevant technical areas. The agency will fill the form biannually; (ii) Surveillance Assessment has been carried out for 16 NPEAs and reaccreditation has been done for 7 NPEAs; (iii) they have given warning to 2 NPEAs for non-compliance of the accreditation scheme provisions by not informing the changes in their skilled manpower.

EC advised QCI-Nabet to organize workshops periodically for the NPEAs to handhold them in maintaining the quality.

#### [QCI-Nabet]

- ii) As regards ascertaining the willingness to carry out exploration in the 51 blocks based on legacy reports along with 10A(2b) cases, EC was informed that willingness has been received from various agencies.
  - EC instructed to convene a joint TCC meeting to allot the blocks to the NEAs/NPEAs. The agencies may submit the proposals in the upcoming TCC meetings scheduled to be held in the month of August, 2025. These proposals to be placed before the EC at its upcoming meeting in September, 2025

#### [NMET and TCC Chairmen]

- iii) Regarding EC's advice to MECL to organize a workshop for all the NER States one day prior to Mining Ministers' Conclave to be organized in Guwahati on 27<sup>th</sup> and 28<sup>th</sup> June 2025, CMD, MECL informed that they are organizing workshops in Mizoram and Tripura in the months of August and September, 2025, respectively.
  - EC advised DG, NMET to review the minutes of 2<sup>nd</sup> North East Mining Ministers' Conclave and in respect of any actionable points, MECL may follow up with the concerned States.

#### [NMET and MECL]

- iv) As regards the release of exploration incentive to agencies for upgradation of mineral blocks from G4 to G3 stage of investigation after completion of G3 stage of investigation.
  - EC was informed that NMET is revising the entire Schedule of Charges (SoC) and the relevant modification will be incorporated in the revised SoC of NMET.

#### [NMET]

- v) Regarding EC's instruction to upload the details of procured instruments on NMET website, EC was apprised that the list of procured instruments has been uploaded on NMET website.
  - EC further advised to (i) add an introductory paragraph citing the wider use of these instruments in mineral exploration activities by the beneficiaries; (ii) the contact details of respective agencies should also be uploaded so that interested agencies may be facilitated to borrow the equipments for their use; (iii) visit the

Department of Science and Technology (DST) portal to study the methodology followed by them for uploading details of equipments.

vi) Regarding ECs decision to review the procurement status of the agencies EC advised DG, NMET to review the individual procurement projects with concerned agencies, for timely procurement and utilization of equipment.

**Decision of EC:** EC accorded approval for pre-closure of above 08 (except Sl. No. 4) exploration projects.

As regard, preclosure of preliminary exploration (G-3) for Limestone in Jaharitola (3.34 km²) & Mundatola Blocks (4.34 km²), Sundargarh District, Odisha, MECL informed that initially the block was taken up for limestone exploration, but during exploration it was

observed that the block contains dolomite (which is a minor mineral). Subsequently, MECL has applied for preclosure of the block citing the reason that dolomite is a minor mineral. **EC** instructed MECL to take special permission from NMET to explore dolomite (a minor mineral) and complete the project. EC further instructed that if there is any other such block where dolomite is present instead of limestone and exploration has been started, special permission can be taken from NMET to complete that exploration project too.

**Decision of EC:** While EC accorded approval of timeline extension of 31 exploration projects, it expressed its displeasure over the delay in several sanctioned projects on account of unnecessary delay in ongoing projects due to forest clearance, as reported by agencies. **Decision of EC:** EC instructed that (i) atleast one DDG level officer from the respective region may be nominated as mentor for each project to assist the NPEAs in carrying out exploration in these RMT blocks; (ii) the project cost at Sl. No. 3 may be kept as tentative and the cost may be further re-evaluated once the new Schedule of Charges of NMET is finalized.

**Decision of EC:** EC ratified the two projects.

#### **Additional Discussion**

- a. Shri Alok Sharma, Technical Expert pointed out that NMET has taken up around 550 exploration projects in last 10 years, creating a dearth of blocks for mineral targeting. Taking up RMT projects through NPEAs is a good initiative in this direction. It will improve availability of areas for prospecting, but will need to be executed in best way for good results.
- b. Shri Naresh Nautiyal, Technical Expert informed that a number of mineral blocks have been successfully auctioned by the Government. While this is encouraging, it also needs to be ensured that mining in these blocks is expedited so that revenues could be generated. The hurdles that these blocks are facing in terms of statutory clearances need to be addressed by the Government to enable early start of mining. Chairman, EC informed that this year the Government is trying to operationalize a number of auctioned blocks and Ministry of Mines has announced an interesting scheme that if any State operationalizes 10% of the auctioned blocks then an incentive of Rs. 300 crores will be given to the State.

c. Shri L. S. Shekhawat, Technical Expert informed that (a) processed lamproite rocks from which diamonds have already been extracted like Chelima lamproite where such processed material is present over 3 square kilometres together with non-diamondiferous lamproites like lamproites of Damodar valley coal fields, should be investigated further for their critical elements content as is envisaged for tailings of basemetals and precious metals in the National Critical Mineral Mission document; (b) further, based on study/review of two reports of investigations funded by NMET it was observed that there is unacceptable level of difference in the values of individual elements of interest in the analytical data of samples and corresponding analytical data of check samples. NMET was requested to address the issue by means of developing a suitable Standard Operational Procedure (SOP).

EC advised (i) to develop a mechanism/SOP to monitor the results of check samples to minimize the discrepancies and maximize the outcome; (ii) further, EC advised **DG**, **NMET** to take a review of the CMPDI and IBM project on geochemical analysis of samples drawn from mine faces, mineral stacks, dumps, tailings, process samples and smelter slags across the country, to assess whether more such projects can be taken up for funding.

d. Prof. Sahendra Singh, Technical Expert suggested to include all the high-resolution techniques like LA-ICP-MS for trace elements analysis, High Resolution Transmission Spectroscopy, Focussed Ion Beam -Scanning Electron Microscopy, High Resolution Transmission Spectroscopy, Atomic Force Microscopy, X-Ray Photoelectron Spectroscopy, Core Hyperspectral Scanning, Mineral Liberation Analyzer, TESCAN Integrated Mineral Liberation Analysis for the investigation of ore samples at nanoscale in the Schedule of Charges being revised by NMET.

e. Dheeraj Pande, Director AMD mentioned that the list of equipments along with their specifications can be posted on NMET website on the pattern of Department of Science and Technology (DST) portal. This would be beneficial for all the agencies to frame the specification of instruments while make procurements. He also pointed that RMT blocks comprise of huge area upto 2000 km² and within the block there is

every possibility that a number of exploration projects might have been executed. Accordingly, the overlapping areas should be excluded from the RMT blocks and exploration be targeted only in the leftover areas.

**EC** instructed to upload the details of instrument along with specifications on NMET website and also on the website of DST.

In the concluding remarks, Chairman, EC commented that with the proposed amendment in the MMDR Act, the scope of NMET is going to increase exponentially to include exploration in offshore areas and overseas. Accordingly, NMET should be ready to take up the new challenges.
