I invite kind attention to the subject and references cited. In this connection, it is submitted that, vide reference 1st cited the Department of Mines and Geology, Telangana has submitted a proposal for kind consideration to sanction financial assistance under NMET fund for procurement of equipment and instruments for establishing the Chemical Laboratory. Through references 2nd cited, the State Government of Telangana addressed the Director, NMET, Ministry of Mines, Govt. of India requesting to sanction the financial assistance under NMET fund for procurement of machinery to expand analytical capabilities to analyze the different geological materials for major & minor minerals and REE to the Department of Mines & Geology.

Through the reference 3rd cited, the 63rd Technical-cum-Cost Committee (TCC) Meeting held on 22nd, 26th and 27th March 2024 has recommended the proposal for approval of Executive Committee for financial assistance from NMET fund to procure machinery/laboratory equipment/instruments etc aimed at enhancing the exploration activities to a tune of Rs.750.78Lakhs.

Through reference 4th cited, the 35th Executive Committee(EC) Meeting of NMET held on 16.05.2024, was communicated wherein it is stated that the financial assistance under NMET funds is not approved as there is no progress in auction of blocks by the Telangana State. The EC has further decided that, the Financial Assistance to the Directorate of Mines & Geology, Telangana should be sanctioned after the issuance of NIT for auctioning of major mineral blocks by Telangana State.

Through reference 5th cited, the NMET has requested this Department to provide the updated status of NIT issued or updated details of auctioned block (if any). In this regard it is submitted that, The State Government vide the reference 6th cited accorded permission to the Department of Mines & Geology, Telangana to Auction 3(three) Limestone Blocks falling in Reserve Forest in Suryapet District as Mining Leases under Section 10B and 11 of MMDR Act, 1957 and publishing of Notification Inviting Tenders(NIT) on 30.08.2024.

Further it is submitted that, the Technical Evaluation Committee held meeting on 23.08.2024 and decided to auction the following 3 Limestone Blocks in Suryapet District with the collaboration M/s.SBI Capital Markets Limited (SBICAPS) as Transaction Advisor and M/s.Metal Scrap Trade Corporation Limited (MSTC- a Central PSU) as Auction Platform.


