Introduction

The National Mineral Exploration Trust (NMET) was established by the Government of India under Section 9(C) of the Mines and Minerals (Development and Regulation) Act, 1957 vide gazette notification dated 14.08.2015. It is a autonomous non-profit body set up to expedite mineral exploration across the country. The NMET has a two-tier structure comprising of a Governing Body (GB) and an Executive Committee (EC).

The apex body is the Governing Body, which is chaired by the Union Minister In-charge, Ministry of Mines ad having members from Union Ministries of Coal, Petroleum & Natural Gas and Atomic Energy. Besides this, Minister in-charge of Department of Mines and Geology from six States Governments are also members of GB.

The Executive Committee is chaired by Secretary, Ministry of Mines and having representatives from Ministry of Coal, Petroleum & Natural Gas and Atomic Energy. The representatives from four State Governments are also members on rotation basis. The Secretary, Mines & Chairperson, Executive Committee administer and manage its activities.

Vision

To use the funds accrued to the Trust for carrying out regional and detailed exploration for augmentation of mineral resource of the country.

Mission

- 1. Exploration and Research:
 - Funding studies to identify, extract, and process deep-seated or concealed mineral deposits.
 - Prioritizing strategic and critical minerals for detailed exploration.
- 2. Sustainability and Modern Practices:
 - Promoting sustainable mining and adoption of advanced scientific techniques.
 - Undertaking studies on mineral development and extraction technologies.
- 3. Collaboration and Coordination:
 - Consulting with the Central Geological Programming Board to set exploration priorities.
 - Facilitating projects that enable granting mineral concessions.
- 4. Advanced Surveys and Projects:
 - Supporting geophysical and geochemical surveys and brownfield exploration for high-risk mineral deposits.
 - Completing detailed exploration where prior stages have been accomplished.
- 5. Capacity Building and Infrastructure:
 - Organizing training programs to enhance the skills of exploration personnel.
 - Establishing a national core repository for geological research.
- 6. Strategic Utilization:
 - Allowing the Governing Body to use the fund for conservation, development, and sustainable exploitation of mineral resources.

Main Services/Transaction

NMET facilitates & incentivize Notified Exploration Agencies (NEAs) & Notified Private Exploration Agencies (NPEAs) to carry out mineral exploration across the country by providing funding support under various schemes. The main activities carried out by NMET are as under:
