**OFFICE MEMORANDUM**

**Subject: Constitution of New Technical-cum-Cost Committee-II (TCC-II) of National Mineral Exploration Trust (NMET) - reg.**

The existing Technical cum Cost Committee of NMET constituted vide O.M. 6/4/2015-NMET/218; dated 18<sup>th</sup> September 2023; will be called as TCC-I. The jurisdiction of TCC-I and TCC-II would be as under: -

Sl.No	Name of States & Agencies
TCC-1	Tamil Nadu, Kerala, Karnataka, Telangana, Andhra Pradesh, Chhattisgarh, Orissa, Maharashtra, Goa, All procurement of Central agencies
TCC-2	Rajasthan, Madhya Pradesh, Gujarat, Jharkhand, Bihar, Uttar Pradesh, West Bengal, Haryana, Himachal Pradesh, Uttarakhand, Punjab, Jammu & Kashmir, Ladakh, All North-eastern States

**5. The TCC shall examine and evaluate:**

- (i) Justification of the proposed projects for regional/ detailed exploration and baseline surveys.
- (ii) Nature and Quantum of various works/ jobs proposed in the project to ensure optimization.
- (iii) Scrutiny and finalization of cost estimates submitted by exploration agencies for project proposals.
- (iv) Scrutiny and finalization of cost estimates of proposals for procurement of machinery / laboratory equipment / instruments etc. for State DGMs /DMGs, Central Government agencies like GSI, IBM or any other agency as approved by NMET from time to time.

The TCC shall submit the recommendations on the above for consideration of EC, NMET.

**6.** The representatives of concerned States DMGs and Regional Mission Head-II, GSI of concerned Regions from which the project has been formulated, shall be invited in the TCC meetings for their comments (both written & during discussion) on the project proposals and to provide the desired information, as necessary.

**7.** If an expert opinion is deemed necessary for evaluation of the project proposals, the Chairman shall invite such expert as a special invitee to the meeting of committee.

**8.** The expenses incurred towards arranging meetings of the Committee will be borne by NMET.

**9.** The non-official members/special invitees of committee are entitled for sitting fee and TA/DA for attending the TCC meetings as per the extant Government of India Rules. The official members of the Committee shall draw their TA/DA from their respective organizations.
